**STIPULATION AND ORDER FOR PAYMENT WITH FINAL JUDGMENT UPON  
DEFAULT, ORDER OF DISMISSAL, AND ORDER DIRECTING CLERK TO  
CLOSE FILE**

The undersigned parties to this action stipulate that:

1. The Plaintiff(s) agrees to accept and the Defendant(s) agrees to pay to Plaintiff(s) **\$3,500.00** plus **\$395.00** court costs and service fees, **\$0.00** interest and **\$905.00** attorney's fees, for a total of **\$4,800.00** in full settlement of the above styled action.
2. Entry of this Judgment is stayed provided Defendant(s) make(s) an initial payment of **\$300.00** on or before **Monday, November 30, 2020**, and additional payments of **\$50.00** are due on the **10<sup>th</sup> of each month** thereafter, **beginning January 2021**, until the total stated in paragraph (1) one is satisfied. In the event of a default, Plaintiff(s) will be entitled to a judgment in the amount of **\$4,800.00** less monies paid.
3. Upon an Affidavit (or notarized letter) of Non-Payment and/or Non-Performance filed by Plaintiff(s), specifying the amount paid and the remaining balance due and/or the non-performance, with a copy furnished to Defendant(s), a final judgment shall be entered against the Defendant(s), **without further notice or hearing**, for the remaining balance of the amount agreed to in paragraph two (2), plus Plaintiff's reasonable attorney's fees and cost in enforcing this agreement.
